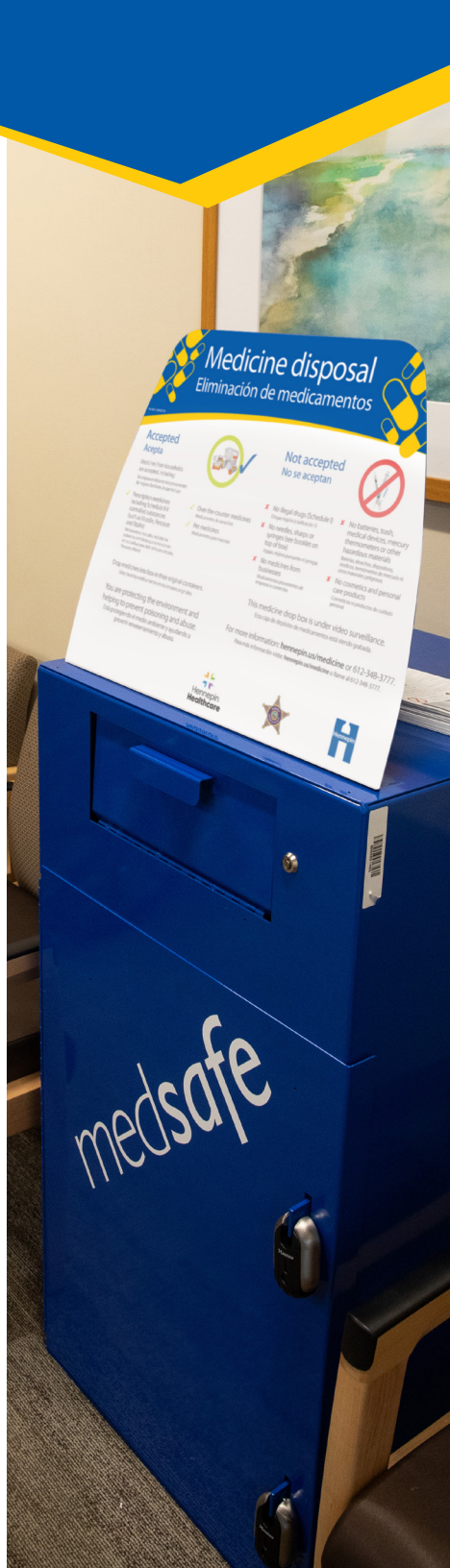
Cov txais tau?

- ✗ Tsis pub tshuaj los lwm lub khws los
- ✗ Tsis pub tshuaj pleev phlu thiab khoom tu yus tus kheej

Cov hluas muaj feem raug phomsij dua.

Ntawm cov 18 rau 25 xyoo, xyoo dhau los muaj li 14.4% siv cov tshuaj kws kho mob muab tsis yog rau mob nkeeg. Ntawm cov 12 rau 17 xyoo, 4.9% siv cov tshuaj kws kho mob muab tsis yog rau mob nkeeg. Ntawm cov hluas uas siv cov tshuaj tsis raws cai qhia hais tias lawv siv cov tshuaj yog muab yoom yim los ntawm niam thiab txiv lub chaw rau tshuaj.

Khaws rau qhov chaw nyabxeeb.

Khaws cov tshuaj koj niaj hnuv siv kom zoo zoo. Cia qhov chaw kom nraimqhov muag thiab txhob pub kom lwm tus, cov menyuam, tsev neeg, phoojywg, thiab tus qhua ncau tau yoojyim.
